## **Author's guide**

**Initially**, the researcher who wishes to publish an article in the law studies journal must have an account in the ASJP and enter the following link:

### **How to propose an article for publication in the law studies journal:**

1 / See the window of the law studies review in the Platform of Algerian scientific journals ASJP /

2 / After entering the magazine window in the platform is directed to the author's help box to download template Template, which shows the formality to send article. Template and available in three languages: Arabic - English - French.

3 / After correspondence of the article with the instructions of the author "template" The article is sent by clicking on the field of

sending of an article and make sure to fill all the existing fields, then send a file as it is in the attached Template file. WORD.

Respect the formal requirements of the article to be published, such as: the basic information of the authors, the font size and type and the method of writing titles, margins and references.

4 / After sending the article it is received by the editorial board of the law studies journal which verifies the extent of the conformity of the formality and the respect of the instructions of the author.

5 / After checking the drafting committee, she decides:

- Accept the article for arbitration and send it to one or more referees in case the article complies with the conditions stated in the author's instructions.
- or reject the article in principle, formally and not objectively, because of the non-compliance with the conditions set out in the instructions of the author, the author of the rejected article can respond to the shortcomings of the formality and submit again the Article.

In both cases, the author of the article will receive the content of the decision of the drafting committee.

6 / If the article is not returned with an arbitration report to the editorial board, the auditor will be recalled and approved for a second period of 15 days, after which the article will be removed from the proofreader if the article that submitted to him is not judged.

7 / After the return of the referee's report on the article, the drafting committee, on the basis of the referee's comments, determines the status of the candidate of the article:

- ✓ An article rejected.
- ✓ Acceptable item.
- ✓ Accepted Article with minor or important modifications.

8 / The decision of the drafting committee on the status of the article on the basis of the reviewers' comments is sent to the author of the article.

- In the case of an item accepted with reservations, the owner must correct the required changes.

- Confirm the publication of articles with a positive opinion:

The article to be submitted for publication must be accompanied by a promise, an honorific declaration - a promise - that the article is intended for publication and that it has not been sent for publication in a publication. other magazine.
