²³- The nature of international crime is inherently political and, in fact, there is a political advisor to the prosecutor's position at the ICTY. Anyone who assumes the prosecutorial role at the ICC will, of course, come with his or her own political perspective on the world and its conflicts, and external political pressure may be exerted in an effort to bring a complaint when it might not be justified or even helpful in a particular political context. However, several factors – notably, a process of vigorous internal indictment review, such as that in place at the ICTY and ICTR; the requirement of confirmation by a judge; and the inevitable acquittal that would result from an unfounded prosecution – would likely prevent any abuse of power by a politically driven prosecutor."
