## **Journal's Aims**

The journal aspires to achieve a number of goals, including but not restricted to publishing original studies in the fields of social and human sciences, and encouraging researchers to engage in the dissemination of productive scientific research, which supports the university's role in facilitation academic exchange and development.

## **Publishing Policy**

The journal is keen to only publish quality articles which meet the following scientific conditions in form and content:

- The authenticity of the material submitted for publication and its non-publication in any previous journal, nor copied from a graduate dissertation.

- Submit article exclusively on the national portal for scientific journals, using the journal's link:

<https://www.asjp.cerist.dz/en/PresentationRevue/394>

- The article should be poured within the journal's template designated for this purpose and made available at the same website.

- Attach a summary in Arabic and another in French, not to exceed one page, and if the article is in French or English Abstracts should be in Arabic and French.

- The title of the article should appear in the three languages (Arabic, English, French).

- The article should be attached to an expanded abstract (Abridged summary) in the English language, within 450-500 words.

- Adherence to the research methodology norms, with a well-arranged bibliography, and use endnotes instead of footnotes.

- For tables and figures (especially big and complex ones), they should be sent in their original form within the attachments in addition to their appearance within the text body so that they can be mended when necessary.
- Articles are not returned to their authors, whether published or not.
- All published research reflects the opinions of its authors, and does not necessarily reflect the opinion of the journal.
- The total number of pages is set between 15-30 pages (within the journal's template), which is in the size of (C5).
- The researcher is obliged to submit a written (original) acknowledgment in which is stated that his/her article adheres to the conditions of the journal.
- The researcher whose article is accepted for publication may obtain a publishing certificate when requested, however the journal directory is not responsible for printing a full copy of it.

### Peer Review Process

The editor may reject it out of hand either because it is not dealing with the subject matter for that journal or because it is manifestly of a low quality so that it cannot be considered at all. Articles that are found suitable for review are then sent to two experts in the field of the paper. **All original articles are subjected** to a double **blind peer-review** process. Reviewers expertise electronic reports are considered as the basis for acceptance, postponement or rejection of any article. The journal's boards can request amendments that are deemed appropriate. The role of the referees is advisory.
