PUBLISHING ETHICS AND MISCONDUCT

1. Publisher's Responsibility:

2. The arbitrator's responsibility:

Contributing to the publishing decision: The arbitrator helps the editor and the editorial board to take the decision of publishing and helps the author in improving the article and make require corrections if needed.

Speed of service and adherence to deadlines: The arbitrator must initiate and expedite the evaluation of the article addressed to him within the deadlines. If this is not possible after conducting the preliminary study of the article, he must inform the editor that the subject matter is outside the arbitrator's scope of work or ask to delay arbitration due to lack of time or insufficient resources for arbitration.

Confidentiality: All information of the article must be confidential to arbitrator; he shall seek to preserve its confidentiality and cannot disclose or discuss its content with any party other than those authorized by the editor.

Objectivity: The arbitrator must prove his review and evaluate the research directed to him by arguments and objective evidence, and avoid arbitration based on his personal, racial, sectarian or other opinion.

Select sources: The arbitrator shall attempt to identify sources and references relating to the subject which the author has not marginalized, and mention that any text or paragraph taken from other previously published works must be properly marginalized. The arbitrator shall inform the editor and warn him of any similar, or overlapping work under his arbitration.

Conflict of interest: The arbitrator shall not arbitrate the articles for personal purposes; therefore, he should not accept the arbitration of articles where there is an interest of persons or institutions or where personal relations are observed.

3. Responsibility of the author:

Preparation criteria: The author must submit an original research and display it accurately and objectively, in a consistent scientific manner that matches the specifications of the articles in terms of language, form or content, according to the journal standards and policy of publication. He must respect the rights of others in the article; avoiding showing sensitive, immoral, tasteful, personal, ethnic, sectarian, counterfeit and inaccurate information and translating the work of others without mentioning the source of the quote in the article.

Originality and Piracy: The author must prove the originality of his work and any quotation, paragraphs or words of others used, must be properly and correctly marginalized. The Journal of
