Submission Guidelines

Sociolinguistics and Discourse Analysis

2. The Journal expects the content of all manuscripts to be original and that the article has not been submitted or accepted for publication elsewhere.
3. Articles can be submitted as CD copies or email attachment sent to : socioanal@outlook.fr
4. Submissions must meet the scholarship standards.
5. Following the peer-review principle, submissions accepted for consideration will be evaluated by two external reviewers.
6. Regardless of the decision of the editing and executive boards to publish a manuscript or not, submissions are not sent back to their authors.
7. The manuscripts represent their authors' ideas and not the journal's.
8. The evaluation of the manuscripts is independent of the reputation or notoriety of the author.
9. Articles should include a brief abstract and a list of keywords.
10. The submission must not be published anywhere or submitted for publication.

Submission Guidelines

Format: Microsoft Word format with single line spacing.

Page: A4 size, Manuscript not more than 15 pages (6000 words).

Abstract: Maximum 250 words.

Keywords: 4 or 5 keywords.
